



Subscribed users will receive a text message from TCI that says (example) "Your Ta Chen Int'l PO#XYZ is ready for pickup at 8500 109TH ST NORTH ENTRANCE, PLEASANT PRAIRIE, WI 53158 location."

There are two methods to **Subscribe** (see below).

The mobile phone user can **Unsubscribe** from receiving any further text messages from the service at any time by TEXTING back the word **BLOCK**.

Method A SUBSCRIBING TO THE TEXT MESSAGE OPTION AT TIME OF ORDER ENTRY

When a customer is entering an order on the TCI customer order entry website, they will encounter the ability to include a truck driver mobile phone number per TCI Pickup location. The buyer will click the **Subscribe** button to allow TCI to send the text message to the driver.
